With the adaptation of advanced technology in public transport and healthcare, services are now more accessible and efficient. Furthermore, the environment will also be more friendly due to lesser traffic congestion and adoption of green technology. For instance, Singapore has released a green plan 2030 where the country target to raise solar energy deployment and expand electrical vehicle charging infrastructure by 2030. These efforts to improve the environment help to ensure environmental sustainability for future generations. Hence, through the use of digital innovations that assist the implementation of plans to ensure a liveable city, urban living today is more sustainable and convenient.

However, such a level of convenience comes at a price that may refute the idea that cities today are necessarily the best places to live in. The price of adopting advanced technology for transport may come in the form of higher taxes which further widens income gap between households. Lower income households would be more severely impacted and their material comfort would fall. The maintenance of these transport systems may also incur opportunity costs where there are lesser government funds to allocate. Additionally, the use of green technology is not a flawless plan as the disposal of electric vehicles could lead to new pollution issues. For example, the carbon dioxide emissions from material processing can be up to 70% higher for an electrical vehicle as compared to a regular vehicle. As a small country, Singapore's limited land and resources make it difficult to manage the disposal of batteries and could cause pollution issues to arise. The higher cost of living and deterioration of the environment would negatively affect the standard of living and hence cities may become worse for living.

Opposing view (Zhitong)

Proponents of city-dwelling point to the higher standards of living and peace of mind as a major pull factor of cities in light of technological advancement. Cities undoubtedly offer a more diverse range of higher-skilled jobs like manufacturing and finance that rural areas are simply unable to provide, as well as better education facilities such as universities and MNCs that allow for individuals to become highly educated and secure a high-paying job in the future. For instance, the GDP per capita in cities is 5-10 times greater than that of more rural areas, highlighting the significant disparity in income and the overall quality of living in cities, as individuals can afford more luxury housing and consume a wider variety of goods such as restaurant meals and television electronics for instance. In addition, cities offer more advanced amenities such as public transportation (MRT and buses in Singapore) which boosts mobility and increases the range of jobs that a person can take on. As a result, their disposable incomes rise and they can thus enjoy a more comfortable life.

However, the assumption that an average person may be able to achieve these goals may not hold, due to the presence of high income inequality in cities. Becoming highly educated and starting from a young age is pretty much a necessity to break into the high-paying and skill intensive jobs that pay well. These are factors beyond one's control and is an endowment rather than an earnable factor through hard work, as good tertiary education is expensive (upwards of 500000 dollars for a medical degree) and years of hard work, which may not be attainable for a low-income immigrant from rural areas, who may also have to help out with chores at home and work part time to support their

families, thus unable to become highly-educated and secure the high paying jobs. As a result, their incomes may not increase at all, and their standard of living remains low.
